“Scheme for Incentive to Green Fodder Cultivation for Perennial and Seasonal Fodder Development in the State”

Introduction.—

The major constraint in the field of dairy development in the State of Goa is the lack of green fodder for the milch animals. The nutritive value of feed and fodder has a significant bearing on productivity of livestock, as such a provision of green fodder for feeding milch animals is very essential. Keeping this in view fodder development has been made an integral part of livestock development.

(3) Rule 12 of Goa Computerised Network Lottery Rules, 2003		"The ticket shall be issued to the player on demand. A player will choose his number as per the Scheme from a given play slip and the number in the play slip will be entered into the ticket vending machine at the retail computer terminal. The ticket will be produced on the pre-printed ticket material where each ticket will be distinguished by a distinct design and alphabetical notation. The tickets shall be serially numbered. The tickets shall bear the facsimile signature of the Secretary, to the Government of Goa, Finance Department. Each ticket shall be assigned a secret mark or code, by the Director. Such mark or code may be changed from ticket and series to series in any draw. Such secret mark or code shall be in the custody of the Government or the Director".	"Mode of Issue of tickets – The tickets shall be issued to the player on demand. A player will choose his number as per the scheme in vogue. The ticket will be produced on the pre-printed ticket material where each ticket will be distinguished by a distinct Serial Number and Bar Code. The tickets shall bear the facsimile signature of the Secretary, of the Government of Goa, Finance Department. Each ticket shall be assigned a secret mark or code. Such mark or code may be changed from ticket to ticket and series to series in all draw".
(4) Rule 16(1) of Goa Computerised Network Lottery Rules, 2003		"The Director shall receive the claim for prize-winning ticket after verifying with the results announced. The tickets produced shall be admitted for payment only after the receipt of genuinity report from the Government forensic laboratory and such other mode of verification checks"	"The Director after having received the claim for the prize shall get the ticket verified from the printer who has printed the ticket and the marketing agent. The tickets produced shall be admitted for payment only after the receipt of genuinity report from the printer and the marketing Agent respectively".
